POSITION CONTEXT & OBJECTIVE(S):

To maintain municipal high-profile areas in the CBD, Botanic Gardens, landscaped and tree assets throughout the municipality to the standards expected by Council

To maintain other municipal parks, gardens and recreational areas (as designated) to the required standard as set by Council.

Assist in the maintenance of Council open space areas throughout the municipality and assets when required.

KEY RESPONSIBILITIES AND DUTIES:

- 1. To maintain designated areas to the required standard to operate plant/equipment efficiently and safely to ensure satisfactory completion of assigned duties within the time frame set.
- 2. Carry out routine maintenance of equipment (small to medium mechanical equipment and plant up to 13.9 tonne G.C.M.).
- 3. Ensure compliance with Council's Health and Safety practices, at all times.
- 4. Competently plan and be creative with floral bed selections and designs.
- 5. To operate/ equipment efficiently and safely adhering to Safe Operating Procedures (SOPS) and Safe Work Method Statements (SWMS) to ensure satisfactory completion of assigned duties.
- 6. To maintain and enhance the designated landscaped areas within the municipality.
- Maintain accurate records of works completed.
- Provide assistance to maintain and enhance other areas of horticulture & arboriculture significance across the municipality
- 9. Willingness to work across a range of areas in the Depot Operations as directed by the Depot Operations Coordinator / Team Leader City Presentation
- 10. Assist work teams complete and review "Safe Work Method Statements" and "Safe Operating Procedures" and any other OH&S requirements.
- 11. Report any workplace safety concerns or risks to Supervisor/Management. Participate in risk assessments for tasks presenting problems and resolve to ensure work team can complete tasks safely.
- 12. Supervise day to day works of trainees, apprentices and labourers when required

SPECIALIST KNOWLEDGE AND SKILLS:

The following knowledge and skills are required to be utilised:

- Identify, discuss and resolve horticulture and arboriculture problems.
- Good knowledge of worksite traffic management regulations.
- Ability to operate and maintain a wide range of small and medium plant & machinery in a safe and efficient manner.
- Knowledge of weed and pest control techniques

MANAGEMENT SKILLS:
