#### Planning & Environment Act 1987 **Warrnambool Planning Scheme** Notice of Approval of Amendment Amendment C205warr

The Minister for Planning has approved Amendment C205warr to the Warrnambool Planning Scheme.

The Amendment came into operation on 18 November 2022, as published in the Government Gazette.

The Amendment implements the recommendations of the Russell Creek Flood Mitigation – As Constructed Flood Modelling (Water Technology Pty Ltd, 2017) and Design of North Warrnambool Floodplain Management Plan - Implementation Works (Cardno. 2010) by applying the Flood Overlay and Land Subject to Inundation Overlay to identified areas of flood risk land, and a number of areas are rezoned from Urban Floodway Zone to Public Park and Recreation Zone or General Residential Zone.

#### **Draft Short Stay Accommodation Local Law**

Council's 2022-23 Budget proposed the introduction of a \$400 fee for short-term accommodation providers.

This proposal was similar to fees introduced by other municipalities to address the inequity between registered visitor accommodation providers e.g. motels and hotels, which pay a commercial rate and must meet strict registration requirements, and those also providing visitor accommodation through newer platforms such as Airbnb, which do not.

In order to implement the new fee, Council has proposed a new local law specific to short stay accommodation. This local law would also introduce a code of conduct to help govern the behaviour of guests.

Council is inviting feedback from the community on the proposal local law.
