Planning and Environment Act 1987 Warrnambool Planning Scheme

Notice of Approval of Amendment Amendment C213warr

The Minister for Planning has approved Amendment C213warr to the Warrnambool Planning Scheme. The Amendment came into operation on 8 May 2025, as published in the Victoria Government Gazette.

The combined planning scheme Amendment and planning permit under section 96A of the **Planning and Environment Act 1987** rezones land in Riverview Terrace, Serendipity Drive and Casuarina Court, Warrnambool from Rural Living Zone to General Residential Zone 1. The Schedule to the Rural Living Zone is also amended by removing the land from the Map in the Schedule. The Amendment also deletes Schedule 2 of the Design and Development Overlay from the land and applies Schedule 17 of the Design and Development Overlay, with a number of minor changes to the content of Schedule 17. Planning Permit PP2022-0060 allows the two (2) lot subdivision of the land at Lot 1 PS 317314K, known as 32 Riverview Terrace, Warrnambool.
