#### Are You Experiencing Financial Hardship?

Council has provisions in place to help property owners who are experiencing difficulty paying rates. For the 2021-2022 year Council has introduced a \$35 rate rebate for those experiencing genuine financial hardship.

This has been introduced in recognition that the rate increase (an average of \$32 per household in Warrnambool) may create a financial burden. Council is currently developing online forms to make applying for the rebate a simple process. Go to **www. warrnambool.vic.gov.au/hardship**

#### Vegetation Clearing in Vicinity of Power Line Conductors

Under the Code of Practice for Electric Line Clearance Council must maintain vegetation clearance around power lines in compliance with the Electricity Safety (Electric Line Clearance) Regulations 2020.
