# **Scheduled Council Meeting**

5.45pm, Monday 6 December 2021, Lighthouse Theatre Studio People wishing to attend the meeting will be required to show proof of full vaccination, or a medical exemption, as a condition of entry.

### Proof of vaccination can be provided at the time of entry via:

- COVID-19 Digital Certificate via the Service Victoria app or mobile device digital wallet.
- Official Australian Immunisation Register certificate with Photo ID
- Printed copy of Immunisation History Statement with Photo
- Printed COVID-19 Vaccination Certificate with Photo ID
- Proof of medical exemption requires a valid original letter signed & issued by a medical practitioner in line with Department of Health guidelines with Photo ID

(There will still be a requirement to QR code on arrival or use the kiosk regardless of the method chosen above).
