People wishing to attend the 1 November 2021 Scheduled Council Meeting to be held in the Lighthouse Theatre will now be required to show proof of full vaccination, or a medical exemption, as a condition of entry.

Proof of vaccination can be provided at the time of entry to the event via:

- COVID-19 Digital Certificate via the Service Victoria app
- COVID-19 Digital Certificate via mobile device digital wallet
- Official Australian Immunisation Register certificate with Photo ID
- Printed copy of Immunisation History Statement with Photo ID
- Printed COVID-19 Vaccination Certificate with Photo ID
- Proof of medical exemption requires a valid original letter signed & issued by a medical practitioner in line with Department of Health guidelines with **Photo ID**

(There will still be a requirement to QR code on arrival or use the kiosk regardless of the method chosen above).
