### Planning & Environment Act 1987 Warrnambool Planning Scheme

#### Notice of Approval of Amendment Amendment C204warr

The Minister for Planning has approved Amendment C204warr to the Warrnambool Planning Scheme.

The Amendment came into operation on 14 April 2022, as published in the Victoria Government Gazette.

The Amendment implements the recommendations of the Warrnambool City Council Advertising Signage Policy - Background Report (2019) by introducing new local planning

policy into the Warrnambool Planning Scheme to guide the location, scale and type of signage within the municipality.

### Planning & Environment Act 1987 Warrnambool Planning Scheme

#### Notice of Approval of Amendment Amendment C209warr

The Minister for Planning has approved Amendment C209warr to the Warrnambool Planning Scheme.

The Amendment came into operation on 31 March 2022, as published in the Victoria Government Gazette.

The Amendment rezones the eastern-most part of the Deakin University Warrnambool Campus at 10635 Princes Highway, Warrnambool from the Farming Zone to the Public Use Zone 2 (Education); applies Category 2 signage controls to the Deakin University Warrnambool Campus (excluding the sports oval complex) in the Schedule to the Public Use Zone; deletes the Specific Controls Overlay (SCO2) and associated incorporated document reference; and includes the entire Deakin University Warrnambool Campus within Warrnambool's urban settlement boundary.
