Conditions of Entry

- 2.1** The 2015 Warrnibald Portrait Prize is open to artists currently residing in the Moyne Shire, the Corangamite Shire and the Warrnambool City Shire.
- 2.2** The subject of the portrait must be a person who has made a significant contribution to local culture, charity, business, sport or politics in our region or has represented our region by contributing in these areas nationally or internationally.
- 2.3** The prize is not open to self-portraits.
- 2.4** The size of the work can be no greater than 90cm x 90cm, inclusive of frame.
- 2.5** Artwork entered must be original uncopied work.
- 2.6** Any traditional 2 Dimensional art medium is permitted (painting, drawing, collage etc). 3 Dimensional works will not be accepted.
- 2.7** Artwork must be supplied ready to hang, with 'D-Ring' fittings attached to verso. Artwork not appropriately prepared can damage other people's artworks, and will not be accepted.
- 2.8** Artist's name, title of work, date and price should be clearly written on verso.
- 2.9** All entries must be delivered to the WAG between 10am and 5pm on Tuesday 14th July, 2015.
- 3.0** Artists selected for the exhibition are responsible for all arrangements and costs, including packing, freight and insurance, in transporting their entry to and from the Gallery. Warrnambool Art Gallery will insure the exhibited artwork (insurance value is the sale price less 40%) whilst on its premises.
- 3.1** At the close of the exhibition all exhibited artists will be expected to collect any unsold artwork by 5pm, Wednesday the 19th of August, 2015. Any unclaimed artworks will become the property of the Gallery and will be disposed of in a manner deemed appropriate.
- 3.2** An entry fee of \$30 is payable upon receipt of a completed entry form.
- 3.3** Only one entry per artist will be accepted.
- 3.4** All entries must have been created within the preceding twelve month period.
- 3.5** All entries must be for sale. A commission of 40% is payable to WAG in the event of sale.
- 3.6** Artists will allow their artwork to be reproduced for documentation, or for promotional purposes.
- 3.7** All entries will be accepted for inclusion in the exhibition, except in the case of there being more than 50 entries. In this instance, the Judges will determine the final selection. Artists whose work is not exhibited will have their entry fee refunded.
- 3.8** The Gallery reserves the right of veto in regard to the nature and/or presentation of exhibition material.
- 3.9** The Gallery Director and Curatorial staff will provide assistance and guidance for the judge as needed.
- 4.0** The Judge's decision is final. No discussion will be entered into.
